Reflections After One Year

One year has passed since Jerry and I moved our ten-year collection of 934 daylily cultivars from Tuscaloosa, Alabama, to La Crosse. Rod Lysne served a surrogate parent for them over last winter, all the while dishing up mounds of generous care, advice, and suggestions as the winter wore on and we feared the worst for them. Rod has become our daylily mentor in Wisconsin! We did lose about 100 cultivars, but there is no way to know whether weather and climate played a role in that loss. We spent this past summer preparing the beds on our corner city lot that faces Grandad Bluff. Because of the unusually cool summer, most of the cultivars did not skip a beat in their growth after being transplanted.

We were delighted that we could make a few judgments about them as early as the end of their first growing season in their new beds. We were most pleased with the performance of four of Harold Harris's yellow cultivars. On the 27th of July, DAYDREAM BE-LIEVER (introduced by T. Petree in 1980), JOEL (1978), EMER-

WDS First Meeting of the Year

It looked like rain around midday last June 17th and Dan Thruman wanted to capture on video tape the first bloom of the season on one of his favorite daylilies, TOUR DE FORCE (Kirchhoff'1985), before it started to rain. He grabbed his video camera and hurried outside into the back yard of his home on White Oak Trail, three miles north of Oregon, Wisconsin. He video taped the small early blooming

ALD DEW (1980),and DEMITRIUS (1977) made a display much grander than we would have thought possible. DAY-DREAM BELIEVER never made its presence felt in Tuscaloosa; I could not recall having seen it bloom in the Southern heat! But in the shadow of Grandad Bluff it was spectacular. For anyone looking for classic, showy, high-performance yellow cultivars for his yard, each of these Harris cultivars is recommended. It is difficult to favor one over the other among these four.

We were heartened that a number of "Southern" daylilies appear to be adjusting well. One of my personal favorites is Kelly Wall's LUCY BETH (1988), which came through the winter in fine form; it is a feminine, daintily ruffled lavender with a slightly vellow throat. The blooms have a more intense lavender hue in the climate here. Two of Kelly's nearwhites: OLD MOUNT VERNON (1977) and SNOWY JUNE (1981), gave every indication of adjusting and performing true to cultivar. Two of Kate Carpenter's semi-evergreens pleased us: NEW SE-RIES (1982) with its distinct triangular form, and SUE ROTHBAUER (1983), which displays a large bloom of deep rich rose with a green throat. Her LAV-ENDER VELVET (1981), a large, pale-colored, spider-like cultivar, was one of the last two blooming cultivars (along with Yancey's 1983 CAMDEN GOLD DOL-LAR) before hard frost.

Before we prepared our garden this summer, we attended the AHS Region 14 Convention and Tour in Montgomery, Alabama in May. It was there that we saw Judith Weston's elegant HOUSE OF ORANGE (1991), with its deep orange sheen and refined form; the bloom is about five inches. Judith herself calls its throat "broccoli green." HOUSE OF ORANGE was at the top of Jerry's must-have list! We expect it to

grow well here as judith began her hybridizing program in Detroit.

On the morning of

the 3rd of June, we

joined twenty members of the West Alabama Daylily Society on a bus ultimately headed for the national AHS tour in Shreveport. We spent the 3rd and 4th of June traveling throughout Mississippi and lower Louisiana. We visited Kelly Wall's Fair Haven garden in Liberty, Miss.; all other visits were in Louisiana: Guidrys in Abbeville, Lee Gates's and Clarence Crochet's gardens in Prairieville; Elsie Spalding's home in Iowa; and Marge DeKerlegand's in Hammond. Dekerlegand's glorious PINK FLIRT was all the rage throughout our tour.

We saw far too many cultivars to comment on even a half dozen that caught our fancy. On the recommendation of Mae Graham, whom we visited at a nursing home in Louisiana, we did acquire Elsie Spalding's rather recent SPRING GRACE. Mae Graham thinks SPRING GRACE is one of Spalding's best cultivars. SPRING GRACE, an evergreen, is an elegant, pure pink (not rose, salmon, coral or mauve) 6-inch, ruffled

bloom. It produced beautiful, wellformed blooms for us here all summer. Now it approaches its real test for our region: Wisconsin Winter. We also acquired Spalding's PRISCILLA'S RAINBOW (introduced by Guillory in 1985); it is an evergreen. Who can resist a rainbow of colors?

In the Guidry garden I was taken with PORCELAIN CA-RESS (1991) because it is noticeably fragrant. It is a dormant cul-Continued on page 8

BYLAWS OF THE WISCONSIN DAYLILY SOCIETY

ARTICLE I NAME

The name of the organization shall be WIS-CONSIN DAYLILY SOCIETY.

ARTICLE II PURPOSE

The WISCONSIN DAYLILY SOCIETY is a not-for-profit organization supporting the enjoyment, awareness, propagation of the genus Hemerocallis by all suitable and appropriate means.

ARTICLE III MEMBERSHIP

- A. QUALIFICATION FOR MEMBERSHIP: Any person, family or business may become a member of the Society.
- B. ACCEPTANCE OF MEMBERS: Members shall be accepted upon payment of the annual membership dues. there are three classes of membership in the Society: Individual, Family or business.
- C: MEMBERSHIP IN GOOD STANDING: A member shall be considered to be in good standing if the annual dues is received by December 31.

ARTICLE IV DUES

The annual dues shall be recommended by the Board of Directors subject to ratification by a majority of members present at the annual meeting of the Society. Written notice of any proposed change shall be sent to all members ten days prior to the said meeting.

ARTICLE VI BOARD OF DIRECTORS

- A. MEMBERSHIP: There shall be eight members on the Board of Directors each serving two year terms with four members elected in the even number years and four in the odd numbered years. A member may be elected to serve only two consecutive terms.
- B. POWERS: The business of the Society shall be under the control and management of the Board of Directors.
- C. MEETINGS: Board meetings shall be held at the discretion of the President of the Board. Special meetings of the Board may be called by the President or by request of any three directors.
- D. QUORUM: At any meeting of the Board of Directors a majority of the Directors shall constitute a quorum for the transaction of business
- E. REMOVALFROMTHEBOARD: Any individual Director may be removed from office with cause or for unexcused absence

- from three consecutive Director's meetings without valid reason. Removal shall be upon vote of a majority of the Directors then in office.
- F. VACANCIES: Vacancies on the Board of Directors shall be filled by the action of the Directors then in office with the term of the appointment limited to the time until the next election of member by the Society
- G. EXECUTIVE COMMITTEE: The officers of the Society shall constitute the Executive Committee. They may hold meetings between the regular meetings of the Board of Directors and shall have all powers of the Board except that they shall not reverse any previous action of the Board. All actions of the Executive Committee shall be subject to ratification by the Board at its next meeting.

ARTICLE V MEETING

An Annual Meeting shall be held each year in the month of October for the purpose of electing Members of the Board and also to receive reports of the committees and conduct the business of the Society. Written notice of the Annual Meeting shall be sent to all members in good standing ten days prior to the meeting.

ARTICLE VII OFFICERS

The officers of the Society shall be the President, Vice President, Secretary, and Treasurer who shall be elected by the members of the Board of Directors at the first board meeting following the Annual Meeting of the Society. No officer shall be eligible to serve more than two consecutive terms in the same office, a term being one year. The principle duties of each officer are:

PRESIDENT: The President shall preside at all meetings of the members and the Board of Directors. The President shall appoint, subject to the approval of the Board, any committees and chairpersons necessary for the conduct of business of the Society and sit as ex officio member of all committees. The President shall be the chief executive officer of the Society, will have general active management of the business of the Society, will see that all orders and resolutions are carried into effect, and will have general power and duties of supervision and management usually vested in the office of President.

VICE PRESIDENT: The Vice President shall preside at all meetings of the members and the Board of Directors when the President is unable to attend and shall assist in coordinating the general activities of the organization and shall chair the Olbrich Daylily Garden Committee. The Vice President and

the Director of the Olbrich Botanical Gardens shall determine the Society's responsibilities for the Olbrich Daylily Garden

SECRETARY: The Secretary shall keep the minutes of the Board meetings including the roll of those in attendance and the minutes of the Annual Meeting and shall be responsible for informing the Board Members of meetings, the membership of the Annual meeting, and conduct the correspondence of the Society. The Secretary shall collect the dues and transmit said moneys to the Treasurer and maintain the current membership roster including mailing address and phone number of each paid member

TREASURER: The Treasurer shall accept all contributions, dues and other moneys collected by the Society, pay the bills of the organization upon approval of the Board of Directors, and keep an accurate record of all receipts, expenses, and transfers. A report is to be given at each Board Meeting and an annual financial report presented at the Annual Meeting of the Society.

ARTICLE VIII COMMITTEES

- A. NOMINATING: The President shall appoint a Nominating Committee and its chair. The Committee shall consist of one member of the Board and two member of the society at large. The nominating Committee shall submit the slate of Directors up for election at the Annual Meeting of the Society.
- B. OLBRICH DAYLILY GARDEN: The President shall appoint members to the Olbrich Daylily Garden Committee and the committee chair shall be the Vice President. The committee shall be responsible for working with the director of the Olbrich Botanical Gardens in coordinating the support by the Society for the display, demonstration plots and gardens of daylilies.
- C. OTHER: The President, subject to the approval of the Board, establish committees as necessary to serve the needs of the Society.

AMENDMENTS

These BYLAWS may be amended by a two-thirds vote of those members present at an Annual meeting of the Society provided the amendment(s) has/have been previously reviewed and approved at a meeting of the Board of Directors and ten days advance written notice of such action has been given the membership.

tivar with a large green throat. Without doubt, one of the most exciting daylilies we encountered was Lee Gates's JUDITH WESTON (1990). The bloom is a leatherly-substanced, 6-inch, ruffled round lemon yellow with distinct black stamens that stand out against a metallic sheen. It was a breath-taking beauty covered in morning dew when we saw it in Lee's garden. A new yellow daylily introduction has to have a high degree of distinction to be noticed in 1992, and we feel that JUDITH WESTON is one worth watching. Is anyone in Wisconsin growing PORCELAIN CARESS, or JUDITH WESTON?

While we toiled away at preparing our own beds this summer, we were delighted to have WDS company around town. Just under

the bluffs on the south side of LaCrosse, Patty and Lu Paulson were landscaping their corner garden lot, with plans for more daylilies, I'm sure! Lu collects large stones and rocks and is using only stones that he himself can handle to design their yard in a highly imaginative way. I was struck by Viette's near-white ICECAP (1980) that made a cool showing in a massive beautifully grown clump in their garden. Lu also landscapes with large clumps of the ornamental false Pampas grass. Byron Annis was instituting a program for redesigning several beds for his garden, making way for new cultivars at his home in an outlying coulee. And in the heart of LaCrosse, Sandy Wheat began her collection of daylilies, and planted them in the back yard of

her home garden. By the summer of 1993 LaCrosse should have some hemerocallis spots ready for Wisconsin Daylily Society visitors. Come visit! **
